ACADEMIC INTERESTS

Studies so far have concentrated on the allosteric regulation of the NMDA receptor by glycine in crude synaptic plasma membranes, post-synaptic density membranes, solubilized NMDA receptors and the elucidation of their anatomical pathways using a variety of lesioning techniques (striatal quinolinic acid lesion and frontal cortical lesion) looking for changes in [³H]Glycine uptake. Striatal glycine and glutamate release studies (exogenous & endogenous). And also interested in the study of Alzheimer's, Huntington's, and Parkinson's diseases. Recently, I started looking at the effects of Obesity in children in the Arab countries. Furthermore, studying and evaluating the knowledge among students at Health Sciences faculties and the graduated Pharmacists to serve the community in a better way.
